



## **Nature Preschool Scholarship Application**

Thank you for your interest in joining Howard County Conservancy's Nature Preschool! For those who qualify, the Conservancy is offering limited scholarships. Scholarships will allow access to financial assistance, offsetting a portion of the costs associated with our Nature Preschool Program. Currently scholarships cover 50% of costs for regular tuition for the 2021-22 school year. After care fees are not included as part of the scholarship program. We hope to award two scholarships.

The deadline to apply is July 1, 2021. Recipients will be notified of their award prior to the start date of programming, if enrolled.

### **Eligibility Criteria:**

- Your child is between the ages of 3 and 5 years old
- You and your family meet the income guidelines. Please note this includes gross family income, estimated income, number of dependents, and any state or federal assistance benefits.

### **To apply, please attach and submit:**

1. This completed application
2. A brief written or typed letter describing why you would love to enroll your child in Howard County Conservancy's Nature Preschool Program
3. If requested, proof of enrollment in assistance programs such as FARM, SNAP, FSP, rental assistance, etc.

If your child is awarded a scholarship, you will be notified of your reduced tuition payment. The remaining balance (50% of tuition) is the responsibility of the child's Parent or Guardian.
